Their appointment shall be subject to following conditions:

- a) The appointees shall report in the office of Director General, Economics and Statistics and at the time of their joining produce following testimonials in original to be verified by Director General, Economics and Statistics before formally allowing them to join:-
 - i. Permanent Resident Certificate (PRC).
 - ii. Date of Birth.
 - iii. Requisite Qualification Certificates.
 - iv. The certificate from the Director Employment that the candidate has liquidated the loan, if availed.
 - v. Any other certificate required under rules.

- b) Appointees shall be on probation for a period of 2 years during which he shall undergo such training and pass the departmental examination as prescribed under Rules.
- c) The appointees shall report to Director General Economics & Statistics within a period of 21 days from the date of issuance of this order failing which their appointment shall be deemed to have been cancelled without notice.
- d) The salary of the appointees will be drawn only after a satisfactory report about their character and antecedents is received from Addl. Director General CID to whom a reference will be made on the prescribed declaration form of the candidate or a certificate of being already in Government service. In case any adverse report is received the appointment (s) will be deemed cancelled without any notice.
- e) The appointments will also be subject to the outcome of writ petitions if any are pending Hon'ble High Court of J&K.
